2009 FIA WORLD RALLY CHAMPIONSHIP

MEDIA PRESS ACCREDITATION ACKNOWLEDGEMENT AND UNDERTAKING

All Media Passes for the Press are issued by the Fédération Internationale de l'Automobile ("FIA") subject to acceptance of the following terms and conditions which the Accredited Party hereby accepts and agrees to abide by:

- 1) Passes shall remain at all times the property of the FIA and the FIA shall reserve the right to refuse any person access to the Rally and/or any Designated Area as such are shown on the Rally Maps at each Event. A Pass may only be used by the named person to whom it was issued and may not be transferred or assigned.
- 2) The Accredited Party hereby personally guarantees the adherence by each Pass Holder to the provisions of this Agreement and all officials' directions, conditions, rules and regulations as laid down by the FIA from time to time and/or as displayed in the Media Centre or elsewhere at the Rally ("the Conditions"), as if such Pass Holder(s) were a party to this Agreement, and without limitation to the foregoing the Accredited Party shall be directly accountable to the FIA for all the activities of such Pass Holder(s) relevant to this Agreement and for any contravention of the Conditions by such Pass Holder(s).
- 3) The FIA has the right to withdraw and retake possession of any pass at any time at their absolute discretion. Pass holders must at all times comply with the directions of FIA officials and/or their nominated representatives.
- 4) The Accredited Party and each Pass Holder acknowledges and accepts that due to the nature of motor sport there are inherent risks and dangers to persons attending an Event and furthermore, agrees to waive any rights/claims he or she may now or at any time in the future have against, and releases from all liability, agrees not to sue and agrees to indemnify the FIA, the National Sporting Authority or Automobile Club connected to an Event, the promoters, International Sportsworld Communicators Limited, any particular team or driver, or other organisations connected to the Event, together with the directors, members, officers, employees, agents, servants, representatives and contractors thereof ("the Associated Bodies"), for any personal injury, death, damage or loss of any kind that the Accredited Party and/or any Pass Holder(s) may suffer or sustain as a result of and in connection with the their presence at the Event or his/her use of the Pass which is not due to the proven negligence of the Associated Bodies.
- 5) The Accredited Party undertakes to indemnify and hold harmless the Associated Bodies together with their representatives from and against any and all claims by any third party for any personal injury, death, damage or loss of any kind suffered or sustained by that third party as a result of the proven negligence of the Accredited Party and/or any Pass Holder(s) at the Event.
- 6) No person shall use any logos and/or trade marks of or relating to the 2009 FIA World Rally Championship (including but not limited to the expressions "World Rally Championship" and their non-English language versions) other than in a factually accurate narrative context (and for the avoidance of doubt for no commercial purposes whatsoever) without the prior express written permission of the FIA.
- 7) No person shall use or make sound recordings (other than for personal use) or radio broadcasts and/or take moving picture images in, of or pertaining to the 2009 FIA World Rally Championship without the prior express written permission of the FIA or the International Sportsworld Communicators Limited.
- 8) The Accredited Party and Pass Holder(s) may only originate still pictures for commercial use solely within print media and for no other use whatsoever (including but not limited to film, television, CD Rom, Internet and other electronic media); they will be solely responsible for obtaining all necessary third party consents for the non editorial use of such still pictures.
- 9) No official timing or results or data relating to an Event may be reproduced, stored in a retrieval system or transmitted in any form or by any means electronic, mechanical, photocopying, recording, broadcasting means or otherwise without the prior express written permission of the FIA except for reproduction by local / national / international press in regular printed publications on sale to the public within 90 days of the Event to which the results/data relate and provided that the copyright symbol and the FIA's address appear as follows: © 2009 Fédération Internationale de l'Automobile, 8 Place de la Concorde, 75008 Paris, France.
- 10) In the event that a Passholder is issued with more than one Pass (irrespective of the type and origin of the Pass or the purpose for which such Pass(es) are issued), the Passholder shall immediately surrender to the issuing authority all Passes (retiring only one Pass issued to such Passholder) failing which the FIA may revoke all Passes issued in his/her name.
